Lawn Care and Weed Control

Lawns in the Village shall be kept up and grass shall not be allowed to grow over eight inches high. Weeds are to be controlled in accordance with state statutes. While allowances are made for <u>natural growth of prairie grasses</u>, the property owner is responsible for the control of noxious weeds. The Village is requiring that all uncontrolled lots be mowed at a minimum of two times a year. Mowing shall be done <u>once</u> between <u>May 15th and June 15th</u> and <u>once</u> between <u>August 1st</u> and <u>September 30th</u>.

If not mowed by June 15th, the village will mow the lot and bill the owner. If the bill is not paid, it will be added to the property taxes with a 10% penalty. In addition, the Village will assess a \$50.00 administration fee for each violation. Any questions can be answered by calling the Village Office.

Sidewalk Maintenance and Snow Removal

De Soto Village Ordinance #2, Section 4: It shall be the responsibility of the property owners in the Village of De Soto to provide for the removal of snow and ice from the sidewalks in front of and surrounding their property. This removal shall be done within 24 hours after the sleet and/or snowstorm. If the property owners fail to do so, the Village will have the snow and/or ice removed. The cost for removal by the village shall be charged at the current village maintenance employee's wages with a one hour minimum plus an administration fee of twenty-five dollars (\$25) per snowfall event. If not paid the cost shall be assessed on the landowner's property tax (WI STAT 66.0627).

Parking Ordinance

For general parking, no Vehicles, Equipment, and or Boats are allowed to be parked on the street in the same place for more than 48 hours, no more than 12 hours after every snowfall.

New Construction and Building Additions

New laws and ordinances make it necessary to get permits and inspections done on additions and or new construction, putting in driveways, decks, etc. Contact the Village Clerk if you have any questions. She can give you the information or direct you to the Village Building Inspector.

De Soto Boat Landing

Annual Boat Landing Permits are available at De Soto Pronto, Bright Spot and the De Soto Village Office. Residents = \$15, Non-Residents = \$30. Daily permits are available at the boat landing for \$5 each.

Burning in the Village

No open burning is allowed without approval of the Fire Chief (this may be required by the DNR). The Fire Chief or his designated officers issue burning permits. Burn barrels are allowed as long as they are permitted and you have a proper container and have a screen or vented lid to keep embers from spreading fire.

Burning permits are issued annually with renewal every January. You can call Chief Chris Mussatti at 648-3303 or Carrie Brudos at 648-2700 to get your permit renewed. Permits are \$5.00.

Persons in violation of the burning ordinance are subject to a stiff fine (state, county and local).

ATTENTION: Residents with Sewer\$ NO WIPES IN THE PIPES \$
Disposable wipes are NOT disposable!!

Please do not put **GREASE**, <u>RAGS or</u>
<u>DISPOSABLE WIPES</u> down your sinks or other sewer pipes. It requires expensive materials and labor to remove the coagulated grease from our sewer systems and your lateral sewer lines. Any repairs to your lateral sewer line are done at the homeowner's expense.
